#### **Power Cost Adjustment**

The Power Cost Adjustment (PCA) for January is \$.00745 /kilowatt hour. This amounts to an additional \$7.45 per 1,000 kilowatt-hours.

The PCA was implemented in 2002 to cover only the increase (or decrease) in power costs (over and above 7¢/kwh) charged to us by our wholesale power supplier, Kansas Electric Power Cooperative (KEPCo) in Topeka. The PCA varies each month depending on the wholesale charges from KEPCo, and is a flow-through on your electric bill.


## Winter Weather Can Bring Power Lines Down

#### Stay Where You Are

You've just been in an accident involving a downed power line. Your first instinct might be to get out and run, but that could cost you your life. In most cases, the safest place to be is inside your vehicle. Wait until electric utility workers de-energize the power. If your car is on fire or you see smoke, escape as safely as possible by jumping out without touching the vehicle and hopping away with both feet together as far as you can. Warn others not to approach the scene.

#### You Should Know:

- Downed power lines are extremely dangerous and even deadly.
- Electric current can travel through the ground and anything touching the ground.
- Stray voltage spreads like ripples on a pond.
- If you step from one "ripple" (voltage) to another, you could be electrocuted.
- Downed lines could be hiding under standing water, ice or debris?

# **2021 Annual Meeting Trustee Elections**

Caney Valley Electric is required to give a summary of the bylaws section on the election process prior to the nominating committee's meeting selecting individuals for a Board of Trustee position. The following is taken from Article III (Trustees), Section 3 (Nominations) of Caney Valley's current bylaws:

"It shall be the duty of the Board of Trustees to appoint, not less than 30 days nor more than 90 days before the date of a meeting at which Trustees are to be elected, a committee on nominations consisting of not less than five nor more than 11 members, who shall be selected so as to give equitable representation to the area served or to be served by the cooperative.

No officer or member of the Board of Trustees shall be appointed a member of such committee. Said committee shall nominate at least two members as candidates for each

Trustee position to be elected at any annual meeting. The committee shall prepare and post at the principal office of the cooperative, at least 25 days before the meeting, a list of nominations for Trustees; but any 15 or more members may make other nominations in writing over their signatures not less than 20 days prior to the meeting, and the secretary shall post the same at the same place where the list of nominations made by the committee is posted... Nothing contained herein shall, however, prevent additional nominations be made from the floor at the meeting of the members."

After a date for the 2021 annual meeting has been selected (due to ongoing COVID-19 concerns) the Caney Valley Board of Trustees will be selecting a nominating committee, tentatively at the April 2021 board meeting. In the past, it has been difficult to find members able to participate on this committee, and to serve on the board if nominated. It would be very helpful to have any member contact a trustee or the cooperative office to let us know you would like to be considered to serve on the committee &/or agree to serve as a board member if nominated.

# **Caney Valley Policy on Power Theft**

Due to problems with some cooperative members found tampering with the meter or other electrical devices and the resulting theft of services, the Caney Valley Electric Board of Trustees implemented a policy on power theft as follows:

Members are advised that Caney Valley Electric will hold members responsible both civilly and criminally for any theft of electric energy and/or meter tampering, pursuant to Kansas Statutes, plus any fees that may arise as a result of same.

#### Kansas Statute 21-3704 Specifies that Theft of Services is:

- Obtaining services from another by deception, threat, coercion, stealth, tampering or use of false token or device.
- "Services" within the meaning of this section includes, but is not limited to ... public or municipal utility services ... and rural electric cooperatives shall be considered public utilities.
- "Tampering" within the meaning of this section includes, but is not limited to:
- Making a connection of any wire, conduit or device to any service or transmission line owned by a public or municipal utility ...;
- ▶ Defacing, puncturing, removing, reversing or altering any meter or any connections for the purpose of securing unauthorized or unmeasured electricity ...;
- Preventing any such meters from properly measuring or
- ▶ Knowingly taking, receiving, using or converting to such person's own use, or the use of another, any electricity ... which has not been measured; or
- ► Causing, procuring, permitting, aiding or abetting any person to do any of the preceding acts.
- In any prosecution under this section, the existence of any of the connections of meters, alterations or use of unauthorized or unmeasured electricity ... shall be evidence of intent to violate the provisions of this section.

### **Recent Vandalism on Our System**

We have discovered incidents of vandalism recently on our system and would like to ask our members' help in keeping an eye out and reporting anything that seems suspicious.

We recently found three chains thrown into our Caney substation, one of which wrapped around a switch. Although fortunately none of these thrown chains resulted in damage, at the very least they could have caused a widespread outage. They also could have caused several thousand dollars worth of damage if sensitive equipment had been hit.

Also, in the early morning of Dec. 8, several cell tower sites on our system were vandalized, with secondary wire stolen and damage caused to our transformers. Outages to the cell towers lasted several hours, and the cooperative's estimated damages are over \$8,000 at this point.

If you have any knowledge of anyone involved in these incidents, please contact us or the Chautauqua County Sheriff's department. Your information will be kept confidential. Thank you.

#### Theft of Services of the Value of:

- Less than \$1,000 is a class A misdemeanor
- At least \$1,000 but less than \$25,000 is a level 9 felony. Indications of meter tampering or obvious theft witnessed by an employee or member of the public will be immediately investigated. The reporting party's name and other information shall be held confidential.

Members will be charged a \$100 fee if an account is found, for a second time, to have missing or tampered-with sealing devices. For any subsequent occurrence, the members will also be responsible for all time and materials needed to repair and install any additional locking devices.

If a member is found to have willfully diverted power to any account for any reason, that account will be immediately disconnected. Power will not be restored until the account holder

> has paid a diversion charge of \$250 plus any estimated lost revenue charges. Any damage to cooperative property will be billed on a time and material basis. Willfully diverting power a second time will result in a fee of \$500 plus any other charges. Management may seek prosecution under Kansas Statute #21-3704 of any person found diverting power or tampering with the meter.
